

2017 CHAPCA Annual Program Report

This has been an exciting year for CHAPCA. We are now in year 2 of the strategic plan and we have made progress on all of our goals. The goals are focused on patients, providers, and members and can be found on CHAPCA's new website, www.calhospice.org. The website itself is an example of a completed goal!

We responded to over 200 phone and email requests for hospice referral and information in 2017. Calls ranged from family members looking for hospice care for a loved one to patients themselves looking for resources after a terminal diagnosis. Our website tool, "Find a Hospice" drew approximately 10,000 hits as well.

We delivered 15 webinars and 2 face to face workshops during 2017, in addition to the annual conference. All together, we have educated more than 350 hospice providers on trends and issues in order to improve the delivery of hospice services.

We continue to work with the California Department of Health Care Services around the implementation of the palliative care benefit for Medi-Cal managed care plans, and we continue to meet quarterly with Medi-Cal staff to ensure providers are paid for their services.

Our project with the ALS Association is well underway, with a best practices paper expected at the end of this year. The Coalition for Compassionate Care, our partner on the best practices pediatric palliative care project, continued to have difficulty finding funding for their part of that project until recently. We plan to conduct several surveys shortly.

Membership slipped this year. We retained 87% of our membership this year, still above the association industry average of 81% retention, but down from the previous year retention of 91%. We have repeated been told by providers they have to make tough choices on where to put their dues dollars, and they are clearly cutting back.

We adopted a succession plan for our staff in case of an unexpected absence, and began work on a plan for filling leadership positions at both the board and staff level. This work led us to engaging in discussion around collaboration with other organizations that share our interests. In July, Sue Negreen, our President and CEO announced to the board that she would like to retire in 2018. Developing a plan for replacing Sue took on new urgency. The board established a work group to work out details.

Finally, CHAPCA sponsored legislation, SB 294, a bill to authorize licensed hospice providers to provide palliative care services to non-hospice patients under their hospice license. The bill received strong support from legislators, and I am very pleased to report that Governor Brown signed the bill into law. It went into effect January 1, 2018.
